The expansion of the one clinician rule will be discussed with options explored. Your questions regarding new pressure ulcer/injury items and guidance will be answered. A comparison of the M1800 ADL/IADL items and the new GG items is essential to achieve accuracy for future outcomes and payment.

OASIS D will be implemented January 1, 2019. Take a deep breath and let Lisa Selman-Holman guide you and your staff into the next realm of OASIS.
