Latest Developments with LHCSAs

This webinar will review a new public need methodology for Licensed Home Care Services Agencies (LHCSAs) and a new Authorization process that will select which LHCSAs can provide home care services to Medicaid recipients.

As of April 1, 2020, a new public need methodology for entities that want to become a Licensed Home Care Services Agency (LHCSA) went into effect. Learn who this will apply to, who is excluded, the factors to be considered in public-need applications, and more.

In addition, the final State Budget includes a provision that establishes a new LHCSA Authorization process that all LHCSAs will have to undergo in order to obtain state approval to continue to provide services to Medicaid recipients. Learn the selection criteria for this process and other details.
