5/7: STAYING COMPLIANT WITH HIPAA DURING A PANDEMIC

Confidentiality of patient and staff's personal information needs to be upheld during the pandemic. Although the Office of Civil Rights has provided home health agencies & hospices some flexibilities, patient privacy is still a major concern. Staff need to understand the appropriate measures to take so that the agency is not at risk.

- Understand the flexibilities under OCR for sharing information;
- Utilizing telehealth technology – what to say & not to say;
- Discuss the protocols that need to be taken to protect patient privacy & to protect the personal information of staff; and
- Considerations for how to speak with patients about an infected staff member.
