**To: Administrators, DPS, HPN Coordinator**

Training to test for COVID-19 is available at no charge to home care and hospice clinicians whose clients may need testing.

Under a grant from the Mother Cabrini Health Foundation, the Home Care Association of New York State (HCA), Iroquois Healthcare Alliance (IHA) and clinical faculty at the Mohawk Valley Health System are delivering web-based training for home health RNs and other personnel on COVID-19 testing procedures that can be conducted at home.
