Home Care, Hospital Associations to Launch Statewide Summit on "Transformative Collaborations"

Novel plan for coordinating and strengthening the health system

ALBANY, NY — Home care and hospital association representatives in New York State are launching a first-of-its-kind statewide summit promoting *Models of Transformative Collaboration* for an innovative, more coordinated and stronger state health care system. The Summit will be held virtually on Thursday, Dec. 2, from 9 a.m. to 12:30 p.m.

Top state officials, health care leaders and statewide participants will speak on new levels and tremendous possibilities of collaborative health care efforts for New Yorkers. Expected participants are representatives of the Hochul Administration, state Departments of Health and Mental Health, state and regional association leaders and representatives from hospitals, home health agencies, physicians, long-term care facilities, mental and behavioral health, health plans, hospice and other continuum partners across the state.

This Summit is part of the broader *Statewide Hospital-Home Care Collaborative* that is being co-led by the Home Care Association of New York State (HCA)/HCA Education and Research, Healthcare Association of New York State (HANYS)/Healthcare Educational and Research Fund and Iroquois Healthcare Association (IHA). Both the *Collaborative* and Summit are supported by a grant from the Mother Cabrini Health Foundation.

"In the Summit and Statewide Hospital-Home Care Collaborative, we are working together to promote a shared vision of system collaboration to improve the functionality of community health systems, health outcomes and overall population health," said HCA's President and CEO AI Cardillo. "We are identifying and promoting ways that hospitals, home care agencies and physicians can further combine as pivotal partners in the provision of service, quality and cost-effectiveness in the care continuum."



"COVID-19 has demonstrated the importance of health system collaboration," said HANYS President and CEO Bea Grause, RN, JD. "When hospitals and partners work together, they accomplish remarkable results. Throughout the Collaborative, we have highlighted truly transformative models of primary and post-acute care partnership that merit consideration and replication across the health care system. We look forward to continuing this work at the upcoming Summit."

IHA President and CEO Gary J. Fitzgerald said "Collaboration is especially critical for the success and capabilities of rural and smaller community health systems. Close partnering and coordination of the local resources extends and strengthens their capacities for health care access and quality." Fitzgerald said: "The models being featured in the *Statewide Hospital-Home Care Collaborative* and discussed in the summit offer opportunities for all regions – rural and small community, suburban and metropolitan."
