


Who We Are

Exhibitor and Sponsor Commitments

To guarantee recognition in conference materials, the Commitment (pg. 7) must be received and your corporate logos and product service description emailed to bwilson@hcanys.org in either jpg or png format by the assigned sponsorship deadlines, or by the deadlines noted above. Commitments that arrive after the due dates will receive recognition as outlined in the category chosen; however, they may not be listed in conference materials due to printing deadlines. No refunds will be issued for cancellations received one month prior to event opportunity. Cancellation prior to that timeframe will receive a refund less 25%.

Upon receipt of the Commitment (pg. 7) by HCA, a confirmation email of acceptance will be sent. Payment in full must be received one month prior to event opportunity. Conference and hotel registration information will follow. No other opportunities will be negotiated. (Those opportunities that include complimentary registrations will still need to complete the conference registration form. Be sure to write in "exempt" in the payment section so you are not charged the conference fee.)

New for 2024! There will be 11 premium exhibit tables for top tier sponsors and HCA members only. For the Annual Conference, please list your top three choices for exhibit space. HCA is not responsible if your exhibit table is near a competitor. HCA has the authority to reassign table locations, as necessary. You will receive a confirmation, via email, of your exhibit location and information specific to your exhibit. Further information will be sent prior to each show, including setup times, shipping information through Clifton Park Rental, details on Internet access, and discounted hotel reservation information.

At each event, you will receive a 6' x 30" table, two chairs, signage and electric access. In addition, you will receive the benefits outlined on page 2. Exhibit fees allow for two individuals from your organization to attend and includes all group meal events, and Welcome Reception. Additional representatives (up to four total) from your organization may attend the Annual Conference at \$350 if your organization is an HCA member or \$550 as a potential member.

The Rules

- Exhibitors who do not arrive by deadline will be removed; no refunds will be issued.
- Refunds for canceling, less 25% administrative fee, are allowed up until one month prior to event.
- Exhibitors shall indemnify and hold harmless HCA agents and the conference venue from all liability.
- Each exhibitor should secure insurance at their own expense.
- Exhibitors must assume full responsibility for compliance with fire, safety and health ordinances. All materials must be fire resistant.
- All exhibit materials must be contained at your table.
 Valuables should be stored in your hotel room during non-exhibit hours. HCA is not responsible for lost or stolen property.
- No more than four representatives per exhibit table allowed.
- Nothing is to be posted, tacked, nailed or screwed to any parts of the building or furniture at any conference venue.
- No decoration or fixture can interfere or block another exhibit; HCA has the right to remove the obstruction.
- No freestanding exhibits will be allowed due to space limitations at any event, excluding standard size pull-up banners. Loud noises or overpowering odors at exhibits will not be permitted.
- All exhibitors and visitors must be registered with the conference and wear name badges,
- No distribution or literature or giveaway items allowed outside the exhibit area.
- Exhibitor drayage and supplied will be handled through Clifton Park Rental for the Annual Conference.
- The Saratoga Hilton cannot accept any shipments from vendors. Shipping of materials must be handled by Clifton Park Rental. Information on shipping will be sent prior to the event
- No open containers or distribution of alcohol at your exhibit table. This is a direct violation of state liquor laws. If noncompliant, you will be asked to leave.


SEE EXHIBIT FLOOR PLAN
