

ADVOCACY

HCANYS's advocacy is the cornerstone of our portfolio. Throughout the entirety of the year, in both Albany and Washington, D.C., the HCANYS policy team is dialed in on programmatic and financial policy developments. Engaging in analysis, debate, negotiation, and education to support and protect the home health care and hospice industry at the federal and state level. HCANYS, along with our government affairs contractors, Hinman Straub and Envision Strategies, worked tirelessly in 2024 toward these goals.

HCANYS advocated for the critical need for workforce investment and support in home health care and hospice, supporting essential funding for provider and health plan services, removing burdensome regulations, expanding access to care, stopping disastrous state and federal home health cuts and misguided proposals, such as the transition to a single statewide fiscal intermediary, and more.


HCANYS participated extensively in state and federal workgroups and councils, advising and advocating for home care, managed care and hospice. We are your voice to the Governor's Commission on the Future of Health Care in NY, the workgroups under the NYS Master Plan on Aging, the regional and state emergency health preparedness coalitions, and more, working to support and improve the state's home health and overall health delivery system. HCANYS also joins the Department of Health's biweekly program advisory meetings as well as the Department's monthly managed care/managed long-term care plan association meetings, addressing issues, needs and challenges for provider and health plan services, and recommending improvements in state policies and funding.

HCANYS also advises other provider and professional associations concerned with hospitals, physicians, public health, health education, and other key areas.

GRANT-SUPPORTED INITIATIVES

As a valued and pioneering community health leader, HCANYS has created new, dynamic collaborations with hospitals, physicians, mental and behavioral health agencies, universities, and other continuum partners, as well as obtained vital support for services, innovation, and health care improvement. These partnerships include a series of grant-funded initiatives made possible through the work of HCANYS in collaboration with government and philanthropic organizations to support the home and community-based field, and home care's role in the overall health care system.

With the state's Master Plan on Aging; the multibillion 1115 Medicaid Waiver; the establishment of nine social care networks and three new workforce investment organizations; and industry-wide emphasis on value-based care, population health, and improved quality outcomes, the resources and opportunities being produced by HCA Education and Research (HCA E&R) grant and program initiatives are invaluable to your service organizations, staff and patients.

INCREASED FOCUS ON SAFETY & WELLNESS




